

**MINUTES OF THE REGULAR SCHOOL BOARD MEETING

1. Board President Carrie Buss called the meeting to order at 7:00 p.m. A roll call of members was taken; six members were present, one was absent.
2. Mrs. Buss led those present in the Pledge of Allegiance to the American Flag.
3. Public Comments: None.

**REPORTS:**

**1. Student Club Reports.**

- a. **FBLA** – Donna Curran, Gavin Gray, Kelsey Georgeson, Kevin Kustief, and Gracelyn Footit reported that on April 9 two members, Gavin Gray and Kelsey Georgeson, competed at the State Leadership Conference in LaCrosse. Upcoming events for FBLA: Members will be voting for next year's officers, and the group is working on a FBLA promotional video for recruitment.
  - b. **FFA** – Gracelyn Footit and Alana Voss reported that FFA had been prepping its chapter applications, annual banquet, and working on its LTEs and CDEs. The Parliamentary Procedure team and several members advanced to Sectionals. FFA member Olivia Lulich took first in her event and will advance to state. The organization is preparing for its May events and working on applications for State Convention.
  - c. **Key Club** – Elizabeth Kolb, Anna Boppart, and Anna McClintock reported that Key Club will be working with FFA to pick up trash on the side of the highway, and will be assisting with the upcoming Sharing Supper. The club is currently planning on selling plants to place in classrooms to improve air quality and to promote responsibility for taking care of the plants.

4. **Breakfast in the Classroom** – Grayside Elementary Principal Bobbi Steele updated the Board on how the Breakfast in the Classroom is working at Grayside. She gave an overview on the strengths and weaknesses of the program. The staff has seen a decrease in tardiness and visits to the nurse's office this year and an increase in social interaction and students' willingness to learn. The District will review the possibility of expanding the program at the other two elementary schools.
5. **Superintendent's Report** – Superintendent Weymouth congratulated the Lyndon Station Elementary School for being awarded the Title One School of Recognition "Beating the Odds" Award for 2017-2018 academic year by the Department of Public Instruction. 3. Motion by Erickson/Berkos to approve the donation from donorschoose.org in the amount of \$1,847.57. Motion carried 6/0.
4. 5. Motion by Rogers/Kryka to accept the employment recommendation of Steven McGlynn for the Olson Middle School Science Teacher position. Motion carried 6/0.
6. Motion by Erickson/Berkos to approve the recommendation of the District Health Insurance Committee and the Finance Committee to approve design changes to the District's WEA health plan of a \$50 specialty network office visit and \$100 non-network office visit; \$75 urgent care charge; and the value choice drug plan of a \$0/\$5/\$20/\$40 co-pay, with a 6% increase for the 2018-2019 school year, effective July 1, 2018. After some discussion, the motion carried 6/0.
7. Motion by Erickson/Berkos to approve the recommendation of the District Health Insurance Committee and the Finance Committee to approve a design change to the District's Delta Dental dental plan of 60% coverage for crowns, with a 3.4% increase for the 2018-2019 school year, effective July 1, 2018. After some discussion, the motion carried 6/0.
8. Motion by Rogers/Kryka to approve the Ready Math Series K-5. After a discussion, the motion carried 6/0.
9. President Carrie Buss thanked her family, former Board President Rick Gruen, the administration, and fellow board members for the opportunity to serve on the board and urged the District to keep moving forward in education. She was presented a plaque in appreciation for her service as a member of the Board of Education (2004-2018). Mrs. Buss was also given a Certificate of Appreciation from the Wisconsin Association of School Boards. Board Members also recognized Pam Holmes for her service on the Board (2014-2018). She will also receive a plaque and a Certificate of Appreciation from the Wisconsin Association of School Boards.
10. Motion by Kryka/Berkos to adjourn to Executive/Closed Session in compliance with WI Statute 19.85 (1) (c) Review employment contract for Lyndon Station Elementary Principal/Director of Student Services. A roll call vote was taken and the motion carried 6/0. The meeting adjourned to closed session at 9:01 p.m.
11. The Board reconvened in Open Session. Motion by Kryka/Erickson to approve the contracts as presented. Motion carried 6/0. Motion made and carried to adjourn at 9:20 p.m.
